

## FRAMEWORK PARTNERSHIP AGREEMENT

### FRAMEWORK AGREEMENT NUMBER 2007-0078/001 FRAME MUNB123

The Education, Audiovisual and Culture Executive Agency ("the Executive Agency"), acting under powers delegated by the Commission of the European Communities ("the Commission"), and represented by Mr J. Fronia, Head of Unit, of the Executive Agency,

HAVE AGREED

on the **Preamble**, the **Special Conditions**, the **General Conditions** and the **Annexes** that go to make up the present framework partnership agreement.

The **Preamble** sets out the context of the partnership established between the parties in order to implement the relevant actions under the Erasmus Mundus programme.

The **Special Conditions** and the **General Conditions** indicate the subject and duration of the framework agreement and the operational arrangements for the partnership.

The following documents are annexed to the framework agreement:

<b>Annex I</b>	Actions planned under the partnership
<b>Annex II</b>	Model of the specific grant agreement for Actions 1 and 2 and its annexes
<b>Annex III</b>	Model of the specific grant agreement for Action 3 and its annexes

The terms of the **Special Conditions**, of which the **Preamble** forms an integral part, shall take precedence over those in the other parts of the framework agreement. The terms of the **General Conditions** shall take precedence over those in the **Annexes**.

Through his signature, the partner accepts the terms of the framework agreement and their application to any specific grant agreement subsequently concluded between the parties.

In the articles of the framework agreement, the generic term "action" shall refer to a one-off action by the partner for which a grant for an action may be awarded.
