CONTINUOUS ASSESSMENT:

Evaluation of theoretical knowledge:

There will be a partial exam and an end that will count with 70% in the final grade, and that will include a type part test and another with questions of development of the theoretical knowledge of the subject. The partial exam will be eliminated with a 7, and to be able to do it it is necessary an assistance of 70%.

Appraisal of practical knowledge:

It is mandatory to complete the internship to pass the course, being essential to attend them and to take a test that validates their knowledge. Likewise, the preparation and delivery of the practice script with the results obtained is mandatory for its correction and consideration. The practices represent 20% of the final grade obtained.

Bibliographic review work: It will cover topics included in the program developed as seminars. The evaluation of this work represents 10% of the final grade and contemplates its individual and / or group preparation, its presentation and its exhibition and defense in class.

In order to apply this evaluation system it is necessary that the theoretical exam grade is at least 4.5 out of 10.

FINAL SINGLE EVALUATION:

It will be held in a single academic act consisting of a theoretical-practical exam. The theoretical part will represent 70%

of the final grade and the practical part 30%.

Students who wish to take advantage of this evaluation modality will have to request it from the Director of the

Department in the first two weeks from the date of enrollment of the student, alleging and accrediting his reasons for not being able to follow the continuous evaluation system.
